To help clarify roles, would it be possible to share a charter or scope of the Commission so we can help de-conflict where the Commission is going and ongoing DHS efforts? Meanwhile, we would be happy to update the Commission on the Department's election systems infrastructure protection initiatives and programs if helpful to ensure that we're successful in our respective missions while not overtaxing or confusing our stakeholders.


